


# Main Draw Off Highway Vehicle Area



Open November 1 – April 9



1. The **MAIN OHV Area is the only area on the Pawnee National Grassland where OHV's are permitted** (and this area is closed April 10- Oct 31).
2. **All OHV's must be registered with the Colorado State Parks.** Two stickers (one on each side) must be on each OHV.
3. Park vehicles and load/unload OHV's in **parking lot.**
4. **OHV's are allowed only in the draw** (gully, ravine, arroyo, etc) **NOT on roads or across the prairie.** This minimizes damage to soils, livestock forage, and fragile vegetation.
5. Please leave gates as you find them.

6. **Violation of the closure or riding outside the designated area may result in permanent closure of the area.** If you see an individual riding where they should not, get a license number of the haul vehicle and a description of the bike/rider if you can and inform the Pawnee National Grassland District Office of the violation.
7. **Licensed (street legal) motorized vehicles may travel anywhere on the numbered roads,** but **NOT** cross-country or on routes that are not numbered or are closed to the public.
8. Please respect the rights of private landowners. The east end of the draw is on private land.
9. Please pack your trash out when you leave.
10. BE SAFE! Please wear a helmet and ride the draw safely. Ride slowly in parking lot.

### **Reasons for Seasonal Closure:**

*Minimize disturbance to wildlife and conflicts with other grassland users.  
Allow vegetation to recover during growing season.  
Reduce erosion of soils.*

### **DIRECTIONS TO MAIN DRAW OHV AREA**

I-25 at Ft. Collins, go east on Colo. Hwy.14 to Ault, CO-----14 miles  
At Ault, go north on US Hwy. 85 to Road 122 (Grover road)----20 miles  
Go east on Road 122 to Road 45-----8 miles  
Turn north on Road 45 to Road 126-----2 miles  
Thru the gate, northeast to the parking lot
